

Section 3 – External Auditor’s Report and Certificate 2022/23

In respect of **HALLOW PARISH COUNCIL WO0066**

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2023; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2022/23

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

We note that the AGAR was approved at a meeting on 15 May 2023. The smaller authority originally submitted Section 2 of the AGAR on a Form 3PM rather than a Form 3 in error. We requested that the exact same details were filled out on a Form 3, including the missing questions about trust funds and for this to be ratified at a subsequent meeting. We have confirmed to the minutes that this took place but the Form 3 that was then submitted was dated on the date it was amended rather than the original date of approval. We have confirmed that the information on the resubmitted Form 3 is unaltered from the original form. The date of approval of Sections 1 and 2 should both read 15 May 2023.

The smaller authority should ensure that it has regard to the level of reserves held when considering future precept requests.
