**DRAFT** Minutes of the Hallow Parish Ordinary Meeting of Hallow Parish Council held on **16**<sup>th</sup> **May 2022** held at **Hallow Parish Church**

In Attendance: 2 members of the Public

1. Apologies for Absence: NONE

2. Declarations of interest and applications for Councillor Dispensations subject to the Localism Act 2011.

Councill Kemshall declared an interest regarding the coins and safeguarding books due to being on the School Governing Board and HK requested a continued dispensation to comment on these points and provide relevant information but NOT to vote. JW declared an interest regarding the request from Heath Close regarding the Jubilee.

3. Public Question Time - It was brought to Councils attention that a member of the public tripped on the uneven pavement at the local plant sale, a photo of said pavement will be provided to the Clerk for her to report this to WCC. Councillors were asked what was happening regarding commemorating the Queens Jubilee (see item 8.1) and it was noted that the area behind the Scout Hut had not been cleared of the vegetation that had been removed for the renovations to take place.

# 5. Neighbourhood Development Plan and SWDP Matters

The SWDP has been formally delayed with no new date been set yet. Following discussions with Planit-X Cllr HK updated Cllrs that it was suggested by Planit -X that a revision of the NDP be done based on the settlement boundary and that this change would be regarded as a material challenge. HK will ask for MHDC to confirm the allocation and settlement boundary triggering a revision of the NDP plan.

- 1. **Solar Farm at Sinton Green** The planning officer has completed his written report however no decision has been made at this point
- 2. Planning Application Consultation M/22/00629/FUL 2 Greenhill CottagesHallowWorcesterWR2 6LH LM proposed objecting to the application since it is "development in the backyard" and access to the site is very narrow.MS seconded and all Cllrs agreed.

### 8. Parish Matters

Heath close enquired as to whether financial aid was offered by the Council towards a street party, Council advised that no support was offered as a decision had been made to support the free fete for the entire community.
