The law

A host of legislation allows parish/town councils to carry out over 50 powers. Every council needs to be aware of WHICH PARTICULAR power they are using when spending money. Councils are 'creatures of statute' and must justify every expenditure with legislation. The main piece of legislation appertaining to constitution and administration of parish and town councils is:

NB: Exclusion of the public and press at meetings for discussion of confidential items is covered by the public Bodies (Admission to Meetings) Act 1960. LGA 1972 Schedule 12A does NOT apply to parish /town councils.

Certain sections of the LGA 1972 have been superseded by legislation in such areas as access to information and councillors' allowances and expenses. If in doubt, clerks should contact Worcestershire CALC.

Other acts in addition to the LGA 1972 stipulate certain powers and duties of parish and town councils as set out in the table below. A **power** is something that the parish/town council **may** choose to do but it is not compulsory. A **duty** is something that the parish/town council **must** carry out.
